*Note: In fields of the chart with “Depends on...rating,” this indicates that whether the sponsor is evaluated depends on how the sponsor does on the evaluation cycle showing. For example, a sponsor with “Depends on 21-22 rating” showing under the 2022-23 column means that if the sponsor receives an Exemplary or Effective rating for the 2021-22 evaluation, then the sponsor will be exempted from the evaluation until the 2024-25 evaluation. However, if the sponsor receives an Ineffective rating for the 2021-22 evaluation, then the sponsor would be included in the 2022-23 evaluation and subsequent evaluation cycles until the sponsor meets the requirements for exemption from the evaluation.

**TBD = To Be Determined. Basically, these are evaluation cycles in which the sponsor may be on exemption if it has met the eligibility requirements or the sponsor may be evaluated. It depends on how the sponsor has done in evaluation cycles that have yet to take place.
