Report Overview

General Description and Significance

The data collected are used to determine the amount of Special Education Part-B IDEA and Early Childhood special education funds allocated to the state. Data submitted to the federal Office of Special Education are aggregated by disability, age, race, LEP status, gender, and poverty status. The December Childhood Count report contains detailed handicapped student counts by disability type, by ethnicity, and by age.

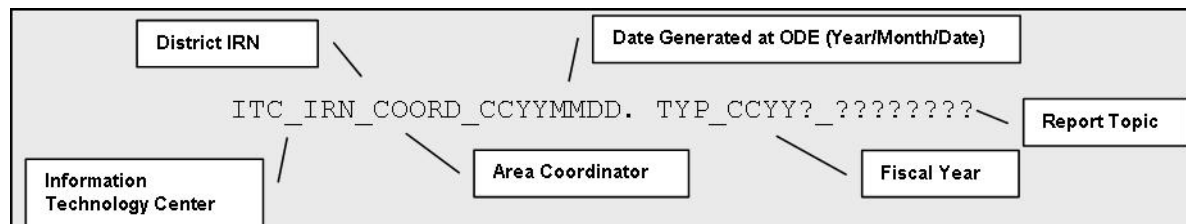
City, exempted village, local traditional public school districts and community schools are required to report data on the number of children with disabilities who are receiving special education and related services in accordance with an IEP on December 1, 2006. These data are to be submitted to the US Department of Education by February 1, 2007.

- Report field names are written in **BOLD SMALL CAPITAL LETTERS**.
- Options (values) for each data element are indicated in *ITALICIZED CAPITAL LETTERS* and are enclosed in quotation marks.

- File names are displayed in **CAPITALIZED BOLD LETTERS**.
- CCYYP denotes the century and year and processing period.

Derived Data Used in Report

Beyond the creation of the handicapped file described above, there are no additional derived data elements used in this report.

Report Selection Criteria

Several groups of students are selected for the report output.

1. Students at traditional public schools:
STUDENT STATUS = "0" and ATTEND/HOME DISTRICT INDICATOR = "0" or "2" or "3" or "4" or "5" or "6" or "7" or "8" or "E" or "C" or "P" or "T" or "S" or "W" or "Z"
2. Students at community schools:

3. Students in Head start, attending chartered non-public schools, or non-residents receiving special education services through your district or staff within it:

Report Sample

Header Information

The first area of the header describes information about the report generation. The upper left section names the program from which the report was generated and the data source. The middle information identifies the producer of the report and the report title. The upper right section states the page number, and the date on which the report was generated.

The second area of the header pertains to the recipient of the report. It identifies the district for which the report was produced, its IRN and COUNTY, and the phone number of the district.

That is followed by a line stating the disability type for the counts on a specific page.

That is followed by column headers that are the same for all pages except 5, 10, and the summary page:

- AGE
- CHILDREN CURRENTLY IN PROGRAM
- Then the list of Racial/Ethnicity Groups. The column headings correspond to the submitted codes of I, A, B, H, W, M, and not reported or invalid code in that order. The EXCLUDED/CODING ERR column contains students with PROGRAM CODES 210041, 210042, 210043 and 211001 or records in which an error condition was found.

The data on this page count **PRESCHOOLERS WITH A DISABILITY '11'** for **AGES 3, 4, and 5** and **OTHER 5 YEAR OLDS**.

The 5-year-old students are counted in two rows, those who are disabled preschoolers and other 5 year olds. Five-year-olds might be preschool or kindergarten students. Because the 5-year-olds who do not have a disability condition of “11” might have either a 217XXX program code or a 210XXX program code, there is a cross-walk between the two sets of codes.
