# **Report Overview**

## General Description and Significance

The purpose of Preschool Units EMIS Staff Report is twofold. First, it helps School Districts and Educational Service Centers (ESC) ensure the accuracy and validity of preschool staff, student, and program data submitted to the Ohio Department of Education (ODE) through the Education Management Information System (EMIS). From this report, school districts, ESCs, and DA-Sites (also known as Information Technology Centers or ITCs) have the opportunity to review preschool special education teacher, adaptive physical education and related service, and summary data.

A second major purpose of this report is to provide source data used to determine foundation funding. Approved preschool unit data from this report is used by Office of School Finance as the source data for which school districts and ESCs receive foundation money in line 23a of their foundation reports (SF3 Reports).



- Options (values) for each data element are indicated in *ITALICIZED CAPITAL LETTERS* and are enclosed in quotation marks.
- Record names are displayed in *italicized bold letters*.
- File names are displayed in CAPITALIZED BOLD LETTERS.
- CCYYP denotes the century and year and processing period.

## **Report Name and Timing**

The file name for the report is:

# **ODE Processing**

## **Process Description**

The student and staff data are submitted by the districts during the processing week and aggregated. The aggregated files are then processed by ODE and incorporated into their files. These data are processed with the allocation data established by the Office of Early Childhood Education to produce this report.

The preschool units staff report is one of the October (K) reporting period EMIS reports released during the October reporting period. Generally, the report is released to DA-Sites early in the week following EMIS Processing. A notice is sent to the OECN Distribution list after the report has been copied to the DA-Sites.

## Data Source

Two sources of data comprise the preschool units staff report: EMIS October data and allocation data collected though the web-based Preschool Units Application during fall.

## 1. EMIS Data

School districts may include preschool students who are at least 3 years old and are enrolled in the district prior to December 1 and their disability is identified. This is an exception to the normal EMIS October reporting rules. Data elements from the following EMIS records are the source data for the preschool units report: *Staff Employment, Staff Demographic, Course Master, Student Demographic, Student Attendance, Student Course, and Student Program* records.

## 2. Allocation Data

In addition to EMIS data, unit allocation data is also a major part of the report. Unit allocation data is the number of preschool special education units which are annually allocated to the school district, by type, from the Office of Early Childhood Education. Allocation data is used in the calculation of the maximum number of units for which a specific unit type can be approved to be funded.


# **Report Sample**

The report is organized into three sections:

- 1. Teacher Section
- 2. Adaptive Physical Education and Related Services (formally Related Services) Section
- 3. Summary Section

Additionally, the report header and comment description sections provide valuable information.

Figure 1 Report Layout and Organization



## Header Information

The first area of the header describes information about the report generation. The upper left section names the program from which the report was generated and the data source. The middle information identifies the producer of the report and the report title. The upper right section states the date on which the report was generated, the page number, and the reporting period to which the report belongs.

The second area of the header pertains to the recipient of the report. It reports the dates on which the Staff data and the Student data were submitted to ODE; note that they do not have to be the same. It then identifies the district for which the report was produced, its IRN and COUNTY, the ITC and AREA COORDINATOR of the district.



That is followed by column headers indicating the data described on each detail line.

## **Detail Information**

## **Teacher Section**

The first section of the report, after the header, will consist of the teacher and student data submitted through EMIS. This section utilizes the Staff Employment, Staff Demographic, Course Master, Student Demographic, Student Course, and Student Program records.

## Data Elements/Calculations

Data elements used on this section of the report are described in the following pages. Please refer to Figure 2, a sample report diagram, as seen below.

**STATE ID #:** The 9 digit alphanumeric code assigned to a teacher when he/she is certified or licensed through the state of Ohio, Department of Education. The *staff employment* record in EMIS is the source for this data element.

If the social security number of the teacher is reported by the district, it will be converted during the aggregations at the ITC into the assigned State ID by the Ohio Department of Education. The State ID is the same number issued on the teaching certificate/licensure.



The State ID is pulled from the *Staff Employment* record reported to EMIS. Only those teachers with a POSITION CODE of "206" will show on this report in the teacher section.

- **NAME:** The name of the teacher comes from the *Staff Demographic* record. It will be in the format of Last Name, First Name, and Middle Initial.
- **TYPE OF UNIT:** Is determined either by the course type as reported on the *course master*, and also determined by the ASSIGNMENT AREA on the *Staff Employment* record. A center-based teacher should have a course master record with a course type of "D08". An itinerant teacher (ITR) must have an assignment area of "999413" on the employment record. Both the *course master* record and the *staff employment* records are the sources for this data element.

If a teacher is a "combination teacher", meaning that the teachers spends part of the time teaching a center-based preschool special education class and also is an itinerant teacher, then it is extremely important that the school district only report 1 (one) *Staff Employment* record with a position code of "206" for this teacher. On the *Staff Employment* record, be sure to indicate 2 ASSIGNMENT AREAS in the first two assignment area positions;

- "999412" center-based teachers
- *"999413"* and itinerant teachers
- **FUND SRC:** Staff FUND SOURCE as reported on the *staff employment* record. A FUND SOURCE must be coded as a "Z" (preschool state unit funding) in order to receive preschool state unit funding approval; thus generating preschool unit funding to the district.

Staff ASSIGNMENT AREAS do not relate to the fund source or FUND SOURCE PERCENT. There is no correlation. Therefore, if multiple ASSIGNMENT AREAS are reported, report the FUND SOURCE and FUND SOURCE PERCENT as they relate to the teacher's position in the preschool special education unit, not each assignment area.

If the district is expecting to receive a fully funded unit for a teacher, then please report 100% in the "Z" fund source percent and 1.0 in the FTE. In this particular case, no percentage should be reported for any other fund source if the teacher is paid out of multiple fund sources. If the district is expecting to receive .50 (half) of a fully funded unit, then please report 50% in the "Z" fund source percent and 1.0 in the FTE. In this case, fund



source percentage(s) could be reported up to another 50% if multiple fund sources are reported.

**\*\*\*** Note: ODE understands for preschool special education unit funding purposes, the fund source percent is not used as indicated in other parts of the EMIS manual. ODE is working to resolve this issue in the future.

#### **PSSE UNIT FTE:**

Preschool Special Education (PSSE)

This is the full-time equivalence of the preschool special education teacher as reported in EMIS, on the *Staff Employment* record. This is a calculated field. The FUND SOURCE, FUND SOURCE PERCENT and the STAFF FTE are the three elements of this calculation.

Where the FUND SOURCE = "Z" (preschool unit funding) the FUND SOURCE PERCENT for the "Z" FUND SOURCE is multiplied by the FTE reported on the staff record.

#### Example 1

If the FTE is = 1.0, and the fund source is = to "Z", and the corresponding fund source % is = to 100%, then the PSSE Unit FTE value is = to 1.0

#### Example 2

If a special education teacher is teaching one class of preschool special ed students, and also one class of school age special education students, and the district is expecting a half (.50) of a preschool special ed unit), then the report 1.0 FTE, one fund source = "Z" and fund source percent = .50. Another fund source and fund source percent may be reported.

## STUDENT HEAD COUNTS: (3 - 4 - 5)

Head count of students, specifically by age (3, 4 and 5 year-olds), and % of time, who are receiving services from the specified teacher. *Student attendance, course,* and *program* records are the source of these data elements.

**50% TIME:** Head counts of students who are counted at 50% percent of time, by age. This means that one child (one head count) will count at .50 towards the stud 3-5 FTE.



- **100 % TIME:** Head counts of student who are counted at 100% percent of time, by age
- \*\*\* Note: Students who are receiving itinerant services will be counted as 50% of time.

Students who are scheduled into a "D08" COURSE TYPE and one of the following COURSE TYPES, "P08" or a second "D08", will be counted in the "D08" at 50% of time.

Students scheduled in a "D08" and who also have a PROGRAM CODE of "220100" (itinerant services), will be counted at 50% of time in the "D08" course.

Students scheduled in a "D08", not receiving itinerant services, and also not scheduled in one of the above mentioned courses, will be counted in the appropriate % of time – as determined by the STUDENT % OF TIME on the student record. If the STUDENT PERCENT OF TIME = 50%, then the student will count towards 50% of time on the preschool units report. Likewise, if the STUDENT PERCENT OF TIME is 100%, the student will be counted at 100% of time.

#### **STUD 3-5 FTE:**

Full-time equivalence of student's ages 3-5, for a specific Teacher, State ID Calculation is determined by the following:

Total head count of students at 50% of time - ages 3-5 added to the total head count of students at 100% FTE.

#### **STUD FTE AGE 6:**

Full-time equivalence of students age 6.

#### **NON DISAB:**

Head count of typically developing students enrolled in the preschool special education course, ("D08" COURSE TYPE). These students will not have a DISABILITY CONDITION (or DISABILITY CODE "11"). *Student demographic* and *course* records are the source for this data element.

#### **FUNDED UNITS PER EMIS:**

Per teacher state ID, this is the amount of an allocated/awarded unit, for which the teacher has been approved and the district can receive preschool special education unit foundation funding. This calculation is derived from



these data elements: PSSE Unit FTE (of the teacher), the student 3-5 FTE, the FTE Age 6, and the allocated/awarded teacher units.

\*\*\*NOTE: this number will never exceed 1.0, nor will it exceed the PSSE Unit FTE.

#### **COMMENTS:**

Comments are brief messages indicating why the staff/teacher unit was not approved to be funded. Further information about the comment may be disclosed in the Comment Section of the report.



## Adaptive Physical Education and Related Services Data Section

The next section of the report displays information about Adaptive Physical Education Services. Formally, "Related Services", this section of the report shows the staff members who are providing Adaptive Physical Education and Related Service services to preschool handicapped students. The staff employment and student program records are the sources for the data elements in this section.

Please refer to diagram 2A, a sample of this section of the preschool units report.

## **Data Elements/Calculations**

**STATE ID#:** The 9 digit alphanumeric code assigned to a teacher when he/she is certified or licensed through the state of Ohio, Department of Education. The *staff employment* record in EMIS is the source for this data element.

If the social security number of the teacher is reported by the district, it will be converted during the aggregations at the ITC into the assigned State ID by the Ohio Department of Education. The State ID is the same number issued on the teaching certificate/licensure.

- **NAME:** The name of the staff member. It will be in the format of Last Name, First Name, Middle Initial. The *staff demographic* record is the source for this data element.
- **TYPE OF UNIT:** A representation, in words, of the position code for related service staff. In this section of the preschool units report, the "Type of Unit" data element is determined by the POSITION CODE found on the *staff employment* record. Valid POSITION CODEs for Adaptive Physical Education and Related Services can be found in the *Staff Employment* Record section.



#### **POS CODE/ASSIGN AREA:**

The numeric representation of the POSITION CODE and ASSIGNMENT AREA as reported in the *staff employment* record. For preschool special education, all ASSIGNMENT AREAS for related service personnel must be *"999412"*.

**FUND SRC:** Staff FUND SOURCE as reported on the *staff employment* record. A FUND SOURCE must be coded as a "Z" (preschool state unit funding) in order to receive preschool state unit funding approval; thus generating preschool unit funding to the district.

Staff ASSIGNMENT AREAS do not relate to the FUND SOURCE or FUND SOURCE PERCENT. There is no correlation. Therefore, if multiple assignment areas are reported, report the FUND SOURCE and FUND SOURCE PERCENT as they relate to the teacher's position in the preschool special education unit, not each ASSIGNMENT AREA.

If the district is expecting to receive a fully funded preschool unit for a **RELATED STAFF, THEN PLEASE REPORT 100% IN THE "Z" FUND SOURCE PERCENT AND** 1.0 in the FTE. In this particular case, no percentage should be reported for any other fund source if the teacher is paid out of multiple fund sources. If the district is expecting to receive .50 (half) of a fully funded unit, then please report 50% in the "Z" fund source percent and 1.0 in the FTE. In this case, fund source percentage(s) could be reported up to another 50% if multiple fund sources are reported.

**\*\*\*** Note: ODE understands for preschool special education unit funding purposes, the fund source percent is not used as indicated in other parts of the EMIS manual. ODE is working to resolve this issue in the future.

#### **PSSE UNIT FTE:**

Preschool Special Education (PSSE).

Full-time equivalence of the staff as reported in EMIS, on the *Staff Employment* record. This is a calculated field. The FUND SOURCE, FUND SOURCE PERCENT and the FTE are the three elements of this calculation.

Where the FUND SOURCE = "Z" (preschool unit funding) the FUND SOURCE PERCENT for the "Z" FUND SOURCE is multiplied by the FTE reported.

For example; if the FTE is = 1.0, and the fund source is = to "Z", and the corresponding fund source % is = to 100%, then the PSSE Unit FTE value is 1.0.



#### **FUNDED UNITS EMIS:**

Calculation derived from these data elements; **PSSE UNIT FTE, STUDENT COUNT USED,** and **ALLOCATED UNITS**. The amount of one unit, for which the district was approved to receive funding, based on EMIS program and staff data. This number may never exceed 1, will never exceed the "PSSE Unit FTE" for the staff member, nor will it exceed the maximum units allocated. There must be enough students reported with the appropriate program codes, and enough PSSE Unit FTE reported, in order to receive the maximum unit allocation.

#### **COMMENTS:**

A brief message indicating the staff/teacher unit was not approved to be funded. Further information about the disapproval may be disclosed in the Comments Section of the report.

#### **STUDENT COUNT USED:**

This is a calculated field on the preschool units report. The calculation is derived by summing the number of students with appropriate 218xxx (documented deficit codes), needed to generate unit funding for particular related service unit. See diagram 2B for preschool 218xxx program codes used in **the STUDENT COUNT USED** field for each preschool related service unit.

#### How "STUDENT COUNT USED" functions:

A total student count is derived for each of the below program codes. The total number of students who have the specific program codes reported, can be seen in the summary section of the report, not necessarily this section. (see the "summary" section of this documentation for more information.).

However, in this section of the report, only the required student count for each individual staff related service "PSSE Unit FTE", is used in this section data element.

#### Example 3

In order for a district to receive 1 unit of speech and language related service unit of funding, report the following:

a.	Position Code	326
b.	FTE	1.0 (or multiple staff members whose
		FTE sums up to 1.0)
c.	Fund Source	Z
d.	Assignment Area	999412



- e. 50 preschool special education children with a communication deficit (program code of 218026)
- f. And must have an allocation/award, from the Office of Early Childhood, of 1.00 Speech and Language related service units.

See the figure 3 below for a reference of the total number of students, with appropriate preschool program codes assigned, needed to generate 1.0 unit of funding, per related service.

Fractional units may be awarded, based on both the student count used for each related service, and the FTE of the related service staff.

## **Data Elements/Calculations**

**TYPE OF UNIT:** Identifies the kind of preschool special education unit. Nine (9) Types will always be displayed on the left margin of the summary report, as seen above.

## PSSE UNIT FTE

Preschool Special Education(PSSE) Calculation derived by summing the total preschool staff FTE reported through EMIS for a particular unit type.

#### **ALLOCATED UNITS:**

The amount of preschool units, by type, for which the district is eligible to receive preschool foundation funding. A district may never be funded for an amount greater than this number.

## **FUNDED UNITS PER EMIS:**

Calculation derived by summing the "Funded Units" for each type of unit. This amount should never exceed the amount of units in operation or amount of allocated units.



#### ALLOC UNITS NOT FUNDED:

Calculation derived by taking the Allocated Units and subtracting the Funded Units.

#### **RELATED SERVICE STUDENT COUNT:**

#### **Related Services (other than preschool psychological services)**

For allocated related services units, other than preschool psychological services, this calculation is derived by summing the appropriate student program codes for that particular related service. The preschool program codes that are used in this section of the report are the same "218xxx" referred to in the Diagram 2B.

For example: the speech and language related service student count is calculated by summing all the children reported by the school district or ESC, with a PROGRAM CODE of "218026".

#### **Preschool Psychological Services Student Count**

If a School District is allocated a preschool psychological service unit by ODE, the calculation is derived by summing the preschool children with a DISABILITY CONDITION of "11" (preschooler with a disability), in the reporting districts' *student demographic* records.

If an ESC is allocated a preschool psychological service unit by ODE, the calculation is derived by summing the preschool children with a DISABILITY CONDITION of "11" (preschooler with a disability), in the reporting ESCs' student demographic records. In addition to these students, the ESC student count for psychological services also includes all preschool students with a disability (DISABILITY CONDITION of "11"), as reported by the Local (not City or Exempted Village) school districts in which it serves. Students with a DISABILITY CONDITION of "11" from City and Exempted Village districts, that the ESC has provided psychological services (including evaluation services) additionally, should be reported by the ESC.

Preschool Special Education teachers must be properly certified. A certification check is completed as scheduled in EMIS processing schedule. If the teacher is not properly certified, then the funded amount for that teacher is reduced to "0".

Preschool Special Education Teachers, **both center-based and itinerant**, who are contracted staff are not eligible to receive state unit funding

## Submission of EMIS Data

It is very important when submitting EMIS data, that ALL records are submitted to EMIS for processing. Because the teacher ID is also reported on the program record for itinerant teachers, it is extremely important that the program record, along with staff records are submitted to EMIS processing at the same time.
