

#### Submitted Data Used in Report

#### **Derived Data Used in Report**

The October Funded FTE is used in this process and that information is derived from matching back to the October database by district and SSID to determine if the student was ADM funded in that district for the October reporting period. The district would not have needed to receive full funding for the student; any portion of ADM funding would meet the criteria.

#### **Report Selection Criteria**

The students on this report are students with a WITHDRAWAL/DROPOUT/TRUANCY REASON = '99' and are being excluded from the EMIS processing because the DATE OF DISTRICT WITHDRAWAL/DROPOUT/TRUANCY PROCEEDINGS is not between the October and February count weeks **or** the student was not funded in your district for the October reporting period.

A student that graduated between Oct. Count Week and Feb. Count Week MUST MEET the following criteria in order for the district to receive funding for the student for the February reporting period, if the student DOES NOT meet the following criteria the student will be on the report.

## **Error Detection and Correction**

These students are being excluded from the February (C) reporting process; if you believe that the student(s) should be included verify the following:

- 1.) The student's WITHDRAWAL/DROPOUT/TRUANCY REASON is a '99', the DATE OF DISTRICT WITHDRAWAL/DROPOUT/TRUANCY PROCEEDINGS and DIPLOMA DATE (if appropriate) is after the last day of your October count week and before the end of your February count week, and the student is reported with a STUDENT PERCENT OF TIME > 0. Correct data in the elements as appropriate.
- 2.) The student was reported as enrolled by your district during the October reporting period and that your district received ADM funding for the student for the October reporting period (check the last SF3 Flow CSV file for the October reporting period). If the student was not funded in your district for the October reporting period because of a reporting error, this information cannot be corrected and the district will not receive ADM funding for the student for the February reporting period.
