Four year Graduation Cohort Report Creation Overview

General Information

This document will give an overview of the new 4 Year Longitudinal Graduation Rate report.

The process will be run and the reports generated for the Yearend (N), Graduate (G), and October (K) reporting periods.

For each reporting period this process will need to be run and reports generated 4 times for each data submission processing. It will be run for 4 different Graduation Rate Cohort Years which will equate to the scheduled graduation of the students in grades 9, 10, 11, and 12.

All JVSD and ESC reported information will be excluded from this process.

Basic Description of Process and Students Included

The determination of which students are in the 4 year graduation rate is based on students who began 9th grade three years prior to the graduation rate being calculated. Students entering 10th grade two years prior, 11th grade one year prior, and students entering 12th grade during the graduation year are added into the group if they were not added in the 9th grade year; these are known as “Transfer In” students.

The information for these students are tracked over the four years of the graduation rate to make sure that we have the most current demographic information. Additionally, to ensure accuracy in tracking student information, ssid changes and ssid deactivations are taken into account.

After all applicable data are pulled for the graduation rate, a process assigns a status code for each ssid; a list of status codes and descriptions are listed below. This process also determines whether the ssid will be included in the denominator and the numerator of the graduation rate. Part of the process to determine whether the student is included in the denominator for the calculation is to determine whether the “Attending/Home Status” of the student allows the student to meet the graduation rate filters. The student will be make it through the graduation rate filter if the student’s “Attending/Home Status” is between ‘10’ and ‘1X’ or is between ‘22’ and ‘29’. Additionally, students with the “Attending/Home Status” of ‘12’, ‘16’, ‘1F’, ‘1I’, and ‘28’ will be excluded.
