## Report Overview

### *General Description and Significance*

The .CSV\_CCYY?\_STU\_GRAD\_TEST\_REQ report shows students that the district has reported as graduating for the current reporting period, and that based upon the information that ODE has, the graduate has not met testing requirements for all 5 subject tests.

This program/process generates a data verification CSV file for all Public School Districts and Community Schools.

The purpose of this CSV file is to inform districts and community schools of reporting issues around students that they have reported as graduates.

### *Report Distribution*

The CSV file is generated only for the public school districts and community schools that have at least one student that will be on the report as defined by the logic below. This process is run and the CSV files will be generated during the Yearend (N) and Graduate (G) reporting periods.

This file is copied to School Districts/ITC’s after each EMIS Processing (with other weekly reports & files that are copied to school districts).

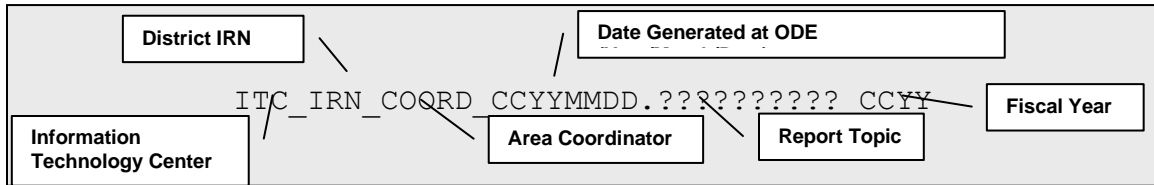

All students are selected that have a Completer record for the current reporting period

**Students are selected based upon the following criteria:**

**For the Yearend (N) reporting period:**

The Withdrawal Reason is a '99'.  
 The District Relationship is '1' and student is not in the Autism Scholarship Program.  
 The Student\_Standing record Withdrawal Reason = '99'

AND

(District\_Relationship code = '1' And both Sent Reasons do not = 'AU')

Or

Either Sent Reason = one of the following:

('CT', 'JV', 'MR', 'OS', 'PI', 'CR'))

Or

(District Relationship code does not = '1'

**Logic**

To determine whether or not a graduate has met testing requirements for all 5-subject tests, the program completes the following process.

As each subject is processed, filters are applied to determine if the scaled score is => 400 or the student is exempt from passing the test. When determining whether the student is exempt from passing the test, the program looks at the record with the most recent test date where the student took the subject test. If the testing criterion has not been met, the information will be deemed as "No Pass" and reflected on the report. If no test records are found with a valid score it will be indicated as "Missing" for that subject on the report.

## **Error Detection and Correction**

For those students that are listed on this report the district should carefully review all of the elements listed under **Submitted Data Used in Report** to verify that the information on the records are accurate.

If the district determines that the information on the *STUDENT STANDING*, *STUDENT ATTRIBUTE – EFFECTIVE DATE*, *STUDENT ATTRIBUTE – NO DATE* and the *STUDENT DEMOGRAPHIC* record are accurate and the student is still on the report the district should report the appropriate results for the student for the subject in question.

If a test from a prior school year needs to be reported, the district should report the information using the actual date of administration of the test.
