It says that we will no longer be able to report scores W and 2.

My question/concern about removing score not reported code W is that in the graduation collection the COVID substitute GEtest record in our SIS will be fatal errors.

My question/concern about removing score not reported code 2 is that we will not be able to report the IOWA or Terra Nova test scores for students transferring into our district with IOWA or Terra Nova Scores that are going to allow them to meet competency or readiness.
