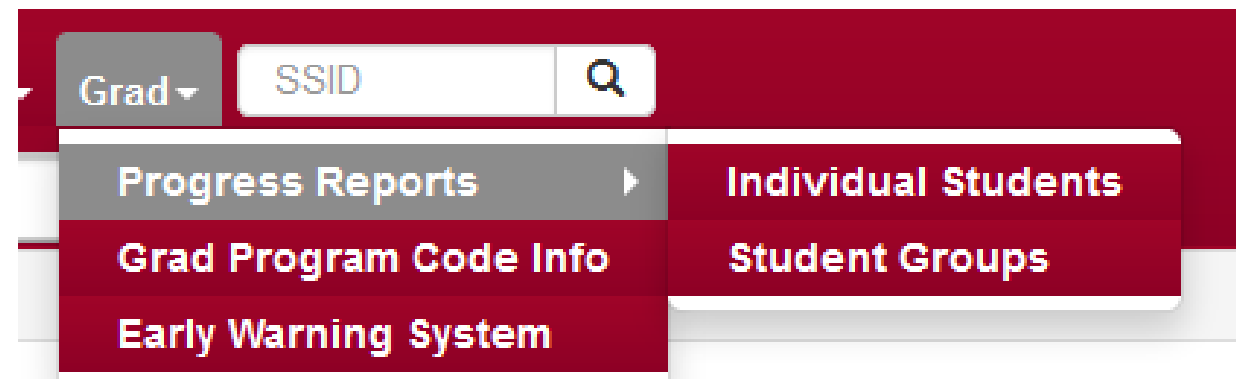


Responsibilities

- The involvement EMIS Coordinators will have for new modules
 - Reporting of needed EMIS data to ODE and SSST
 - All modules will use the data from various collections
 - Serving as a general resource on how ODDEX works
- EMIS Coordinators are not expected to be the primary users of any of the modules we are discussing today

Progress Towards Graduation (PTG)

- Tool to provide access to a student's graduation progress
 - Competency
 - Readiness
 - Courses
- Data for students enrolled or students claimed
- Guidance or enrollment staff
- Navigation Bar



PTG

- Leverages data reported to EMIS in various collections
 - Beginning, middle and end-of-year
 - Grad Credit Progress
 - Staff and Course
 - End-of-course, Career Tech, Alt Assessments, Other Accountability Assessments

PTG

- Data Sources

- GI, FS, FD (general enrollment and subgroups)
- GC (credits towards graduation)
- GQ (grad seals, WBL, alternative competency)
- GE, FE (exemptions for EOC assessments)
- FA (competency and seals)
- CN, GN (alternative competency)

Access to PTG

- Access to ODDEX/PTG is obtained when your district's OEDS Administrator grants roles
 - Data View-PTG
 - Superintendent
 - Treasurer, Business Manager, Assistant Treasurer
 - Coordinator-EMIS, Supervisor-EMIS, Director-EMIS
 - Data View-ODDEX Records Grad
 - ITC staff with SDC access
 - Have access by default, no special roles are needed





EMIS to PTG Reports

- A Data Dictionary will show source of data for each field
- If something does not seem correct on a report, use to determine if the right data has been submitted
- Some examples:

ENGLISH ASSESSMENT MET REPORTING INF	Based on data reported on the Student Assessment (FA) Record, the LEA reporting the English assessment on which the student first met the English competency requirement	IRN of the reporting LEA where the student first met the English assessment criteria.
ENGLISH ASSESSMENT MET TYPE CODE	Based on data reported on the Student Assessment (FA) Record, this code indicates the type of English assessment taken (i.e., standard or with accommodations) when English competency	Indicates the type of English test taken when criteria first met.
ENGLISH ASSESSMENT SCORE MET DESCRIP	Based on data reported on the Student Assessment (FA) Record, the score achieved on the English assessment on which the student first met the English competency requirement	Description of the English criteria met. Either regular score or component via grade.
ENGLISH ASSESSMENT RETEST FLAG	Student Assessment (FA) Record	Flag indicating whether the student was assessed in English more than once.
ENGLISH SPECIAL EDUCATION GRADUATION	Student Special Education Grad Req (FE) Record - Exemption	Flag indicating whether the student is exempt from the consequences of the English assessment.
ENGLISH SPECIAL EDUCATION GRADUATION	Student Special Education Grad Req (FE) Record - IEP Date	Date of the IEP on which the the English exemption was determined.
ENGLISH SPECIAL EDUCATION GRADUATION	Student Special Education Grad Req (FE) Record - IEP Date Type	The type of IEP on which the English exemption was determined.
ENGLISH COLLEGE CREDIT PLUS ALTERNATE	Flag is set to Y if student reported with Program Code 520100 or 520101 on the Student Program (GQ) Record	Flag indicating whether the student met English competency via CCP alternate path.

PTG

- Rollout will begin this month
- Will start with credit reports
- By fall, all reports will be available and reflect all data for this school year
- Major promotion and training for the field in the fall

Early Warning System (EWS)

- Module to assist districts in identifying students that may be at risk to not graduate on time
- Guidance staff
- Available in ODDEX during the 2023-24 school year

Access to EWS

- Access to ODDEX/PTG is obtained when your district's OEDS Administrator grants roles
 - Data View-PTG
 - Superintendent
 - Treasurer, Business Manager, Assistant Treasurer
 - Coordinator-EMIS, Supervisor-EMIS, Director-EMIS
 - Data View-ODDEX Records Grad
 - ITC staff with SDC access
 - Have access by default, no special roles are needed

EWS

- Leverages data reported to EMIS in various collections
 - Beginning, middle and end-of-year
 - Grad Credit Progress
 - Student Course Grade
 - End-of-course, Career Tech, Alt Assessments, Other Accountability Assessments

EWS

- Data Sources

- GI, FS, FD (demographics, attendance)
- CN, GN, FR (course grades)
- GQ (extracurriculars)
- GD (suspensions and expulsions)

EWS Indicators

- Three high level indicators of students who should be examined regarding graduation risk
 - Absent for 10% of school
 - Have a suspension
 - Failing grades
- In addition to statewide criteria on these items, each district will be able to configure their own threshold

EWS Risk Levels

- In addition, the system will assign a graduation risk level (low, medium, high, ultra) based on points assigned in several areas
- Points in some areas are all-or-nothing, others vary by the amount
- In addition to areas with indicators, includes some demographic information, assessment performance, years retained in school, number of buildings attended, and extracurriculars (lack of)

EWS

- System will be released this fall
- Will be important to keep data up to date for the system
- Same data dictionary will be provided for this module

Student Support Intervention Inventory (SSII)

- Module that will allow districts the ability to assign and catalog interventions for a student at risk of not graduating on time
- Guidance and other staff throughout the district
- Available in ODDEX during 2023-24 school year

Using SSII

- Import lists of students or use list of students identified in EWS
- Configure interventions and tiers that district will use to help students overcome risk of not graduating
- Within ODDEX, students assigned to interventions
- Within ODDEX, staff will track notes on interventions
- Will be able to export assigned interventions, which may eventually be reported to EMIS as program codes

Child Nutrition Direct Certification (CNDC)

- National School Lunch Program certification process
 - Not new to districts, only new to ODDEX
 - Legacy CNDC UI was not user friendly
 - Cumbersome
 - Time consuming
 - Repetitive work required
 - Much of data users uploaded each month existed in EMIS

CNDC

- New vs Old
 - All data is cumulative
 - Historical data available starting with 2023-24
 - User Interface tools to better qualify students for benefits
 - Matching process will run automatic weekly using latest SCR submitted enrollment data

CNDC

- Available in ODDEX starting in 2023-24 school year
- Navigation Bar



Access to CNDC

- Access to ODDEX/CNDC is obtained when your district's OEDS Administrator grants roles
 - Generally roles will be granted to district Food Service personnel
 - Verifier-CNDC
 - Allows user to manually match, unmatch and remove eligibility for students
 - Data View-CNDC
 - Allows user to view data



Access to CNDC

- Access, continued
 - Superintendent
 - Treasurer, Business Manager, Assistant Treasurer
 - Have access by default, no special roles are needed
 - Roles can be granted to EMIS-Coordinators if needed
 - By default the EMIS-Coordinators nor ITC staff will have access to this module



CNDC

- Login point is at OH|ID for all users
- Leverages EMIS reported data for all enrolled students
 - Student Cross Reference (SCR) data
 - Earlier submission of SCR data by non-CEP districts needed
- Districts can improve their match and certification rate
 - Starting next year all districts can submit address and guardian information thru EMIS contact collection request
 - Upload is optional to include the same data

CNDC

- Potential students eligible for Free and Reduced benefits are provided by
 - Ohio Department of Job and Family Services
 - Ohio Medicaid
 - Data only used for child nutrition benefits
 - To use data for economic disadvantage in EMIS, parent or guardian must give permission in writing
