Reporting GY Assessments

- New for FY18- WebXam reporting by course
 - New assessment codes assigned by course subject code
 - Report both course level and program of concentration assessments
 - Courses reported with numeric score
 - POC reported with N,P,A
 - Both sets of results provided by CETE

Reporting GY Assessments

- A new missing list to be added for GY reporting
 - Must report an assessment record for all students who complete 25% or more of the course
 - If no assessed, report record with score not reported reason
- Able to use CCP course in place of WebXam, but still report GY record as proxy

Reporting GY Assessments

- Able to use Industry Credentials (GW) in place of GY for entire program in FY18
- Starting in FY19, able to do some mix and matching between GY and GW
 - If student waiting on a GW result, may have to report GY with score not reported to remove student from missing list
- See the Assessment Matrix on the ODE CTE web site for details on valid GWs

Additional Accountability Reports

Assessment

- Given the assessments (GY & GW) reported...
 - Has the student met the assessment requirement for the reported program of concentration (POC)?
 - What POCs have the correct assessments?
 - Are they Advanced, Proficient, or Not?

Participants

- Who is enrolled in a course?
- Is the course funded for the student?
- Has the student earned credit?
- Has the assessment been reported?
- Is the student included in enrollment?
- Is the course aligned to a reported POC?

Concentrators

- Who are the concentrators, current year and prior years, who have not yet exited?
- Is the student enrolled in an aligned approved course?
- Will the student be in the March D cohort for the next year?
- What is the student's assessment status?
- Is the student in a non-traditional group?
