# FY14 Graduate

- ▶ Include diploma information and all data necessary to verify that the student has met CORE and testing graduation requirements
- ▶ File(s) must be uploaded through the Data Collector Data Sources tab
- ▶ Submissions: June 13, 2014 - November 14, 2014
- ▶ Reports coming soon

# FY14 Financial

- ▶ Reopen with all record types
- ▶ All districts should review EXPND\_AMT\_BY\_CAT reports for accuracy and resubmit data as needed
- ▶ Traditional districts should pay particular attention to the building-level allocations included in the updated EXPND\_AMT\_BY\_CAT reports
  - Expenditures that are not reported with an OPU will be allocated to individual buildings within the district
- ▶ An updated EXPND\_AMT\_BY\_CAT report explanation will be posted to the ODE website describing how expenditures are allocated to buildings

# FY14 Yearend Planned Supplemental

- ▶ Does not include K-3 related data
- ▶ FY14 calendar (DL only)
- ▶ Special Education (GE and FE)
- ▶ CTE information on FN (ignores Read Diag)
- ▶ CTE Assessments
- ▶ Open soon, will overlap other 14N K-3 supplemental

# FY15 Calendar

- ▶ Initial window will reopen to allow for collection of calendar data by districts who did not meet requirement during original May-July timeframe
- ▶ Once data more complete, will open window to end of year
- ▶ New report coming- actual calendar

# FY15 Retention

- ▶ Planned close today, however...
- ▶ Next week reserved to issue resolution and possible extension of deadline
- ▶ Review GEN\_ISSUES
- ▶ Focus on 3<sup>rd</sup> grade students
- ▶ Will be added to Report Card at some point

# Student Cross Reference

- ▶ Required for all EMIS reporting entities.
- ▶ Updated student admission and withdrawal data must be submitted within 30 days of the change in student status
- ▶ Application access coming next week
- ▶ Will open with review of own data and history
- ▶ Roles can be assigned in OEDS at any time
- ▶ Should not wait on application to submit data



# Community School Enrollment (SOES)

- ▶ Required for all community schools
- ▶ For school funding, federal reporting, and other required ODE reporting
- ▶ Populates the ODDEX SOES module and meets EMIS data reporting requirements for community schools
- ▶ FY15 data without flags being used for October payment to CS, but not for LDR deduct
- ▶ Flagging by resident districts to start soon

# Community School Contact (SOES)

- ▶ Required for all community schools
- ▶ GI, FF, and FG record types, labeled “S”, must be uploaded to the Data Collector Data Sources tab
- ▶ Will cause student name and contact information to be displayed in ODDEX SOES module
- ▶ Will open soon
- ▶ Resident districts and community schools will refer to this data to help resolve conflicts regarding students
