- Added Level 1 validation (warning/critical) checks to highlight cases where a DN attribute is very close to the end of the statewide testing window for assessments ASMTFG3ELA, ASMTSPRELA, and ASMTSPRMSS to help districts in case they are reporting inaccurately (see Change 23-145):
 - DN.0040 – the attribute start date is within 6-10 days of the end of the test window
 - DN.0041 – the attribute start date is within 5 days of the end of the test window
 - DN.0042 – the attribute start date is a weekend day
- Updated Level 1 validation check GE.0023 to include NIEP (see Change 23-149).
- Updated Level 2 FTE reports removing rows where the value of the FTE across all dates is zero. This will also ensure that the row counts displayed for each report match the number of rows in the report:
 - (FTES-005) FTE Daily Summary Report–Students District is Educating
 - (FTES-006) FTE Daily Summary Report–Students Initially Funded at District
 - (FTES-007) FTE Daily Summary Report–Transfers
