Reporting Gifted Education Services

- 1) Only report gifted education services if the district provides these services consistent with the gifted operating standards.
- 2) Only report gifted education services if provided during the regular school day with flexibility allowed for the scheduling of district-approved internships or mentorships and higher education coursework, including credit flexibility.
- 3) Service placement criteria must be written, objective criteria. Grades and teacher recommendations cannot be used to exclude students from service. Service criteria shall not unduly restrict access to gifted education services.
- 4) Only report students as served if a qualified service provider is implementing a Written Education Plan (WEP) appropriate for the student's area(s) of identification.
- 5) General education teachers (including teachers of honors, Advanced Placement (AP), and International Baccalaureate (IB) courses) who are designated as gifted education service providers must receive professional development in specified gifted education competencies and receive ongoing assistance with curriculum development and instruction from an educator with gifted licensure or endorsement. Professional development must meet specified clock hours each year over four years with on-going clock hours as determined by the district in subsequent years.
- 6) Trained arts instructors designated as providers of gifted education services in the visual or performing arts are not required to meet the gifted education professional development requirements detailed in the gifted operating standards. However, these service providers still need ongoing assistance from an educator with gifted licensure or endorsement.
- 7) Higher education personnel who are providing gifted education services are not required to receive professional development in gifted education or receive ongoing assistance. However, the district must attach a copy of the syllabus to the Written Education Plan (WEP) and then provide a copy of the WEP to the instructor of the higher education course.
- 8) Districts may report identified students on formal credit flexibility plans as receiving gifted education services.
- 9) Districts may report students who are on formal Written Acceleration Plans (WAP) as receiving gifted services during the first year of the acceleration. Professional development in gifted education is not required for an acceleration to count as a gifted education service.
