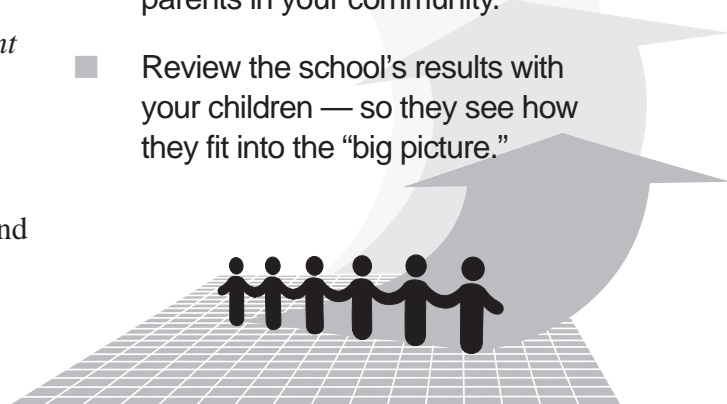
The purpose of this report card is to provide you with information about how well your local school is doing — where it is succeeding and where there is room for improvement.

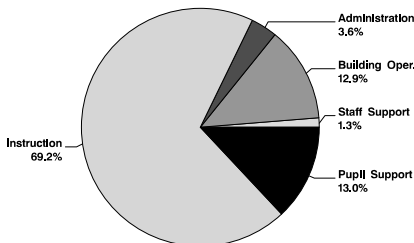
What To Do With This Information
