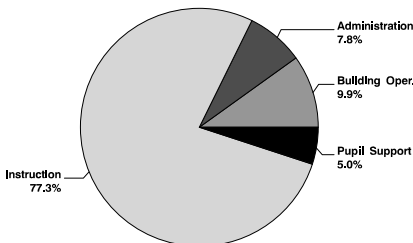
What To Do With This Information
